PUBLIC AFFAIRS & EXPOSURE MANAGEMENT FORECASTING

Increasingly, corporate management must pay attention to the softer issues, issues well beyond the metricizable, accountable, and measurable. In fact, business school education lags far behind in the non-scientific, often highly emotional areas of public affairs management and dealing with corporate exposures.

This has been an area of special knowledge for James E. Lukaszewski, *ABC, APR, Fellow PRSA*, beginning during his days in Minnesota state government where he worked both for the governor and in a state department. Since 1987 Jim has served as a consultant to Headquarters U.S. Marine Corps for General Officer media relations training and as a civilian advisor. He lectures annually at the U.S. Marine Corps East Coast Commander's Media Training Symposium. He has served as a civilian advisor to the Office of Foreign Disaster Assistance of the Agency for International Development, various divisions of the U.S. Forest Service, and the U.S. Environmental Protection Agency.

Government-related issues, of course, overlap with business issues. Jim has developed a proprietary approach to dealing with the exposures organizations experience due to issues in the public domain. He calls it his, "Exposure Management and Surveillance Process." It consists of four phases:

- Phase I: Identify Corporate Exposure Sources/Issues/Threats
- Phase II: Establish Response Priorities Based on Impact, Likelihood of Occurrence, Possible Collateral Damage Generation, and Long Term/Short Term Effect
- Phase III: Develop Confidential Exposure Reports With Limited Distribution to Management
- Phase IV: Quarterly Exposure Review Meetings by the Exposure Management and Surveillance Process Team (EMSP)

This process ensures a continuing look at the most important, essential, and urgent exposures the organization can face. Lukaszewski teaches this process to corporate clients.
